RE: Board of Education Special Meeting

The following actions were approved by the Board of Education at a Special Meeting held on Wednesday, August 25, 2010. Please inform the appropriate staff members in your school building.

1. Trustee's recommendation to appoint Donna Hochman to act as the voting delegate (Edward J. Murphy, Jr. to be the alternate) to represent the District at the NYS School Boards Association's Annual Business Meeting during the Convention in NYC on October 21-24, 2010.
2. The Superintendent's recommendation authorizing Patrice Stango to act as the School Purchasing Agent for the 2010-2011 school year at an annual stipend of \$4500.00.
3. The Superintendent's recommendation to accept the donation of a sign to the Alleghany Avenue Elementary School from Marguerite Danaher, representing Edward Jones Investments.
4. The Superintendent's recommended high school field trip to Minisink Valley HS in Slate Hill, New York for the Girls Varsity Volleyball Team to participate in a volleyball tournament on September 11, 2010.
5. The Superintendent's recommended annual agreements for the 2010-2011 school year.
6. The Superintendent's recommended Budget Transfers over \$5,000.00.
7. The Superintendent's recommendation appointing Coordinator of Athletics, Physical Education and Health Anthony Amesti the position of Title IX Compliance Officer for the 2010-2011 school year.
