NOT, THEREFORE, BE IT RESOLVED, that the vacancy in the office of Board of Education created by the resignation of Robert Brandenberger be continued until the next regularly scheduled annual Board election and vote on May 17, 2011.

10. SUPERINTENDENT'S RECOMMENDATIONS

a. Recommendation: Closing of E. W. Bower Elementary School

Recommended Action: Upon a motion made by _____,
Seconded by _____, the following resolution is offered

WHEREAS, the Board of Education of the Lindenhurst Union Free School District has a fiduciary responsibility to the Taxpayers, Parents and Students of the District to explore ways to reduce expenses and operate more efficiently, while still meeting the educational needs of its Students, particularly in light of the current difficult economic times and the reductions in state and federal aid facing the District; and

WHEREAS, the Board of Education has carefully reviewed the demographic study and projections for student enrollment prepared by Western Suffolk BOCES in 2009 and updated in July 2010; and

WHEREAS, the Board of Education has scheduled and held numerous community workshops and forums to explore different options for the reorganization and increased utilization of the District's elementary schools and have received extensive input from the public on these issues; and

WHEREAS, the Board of Education has carefully studied and reviewed the Educational Impact Statement prepared by the Superintendent of Schools in regard to the proposed closing of the E.W. Bower Elementary School beginning with the 2011-2012 school year; and

WHEREAS, the Board of Education published Notice of the proposed closing of the E.W. Bower Elementary School and Notice of a Public Hearing on that issue pursuant to Section 402-a of the Education Law; and

WHEREAS, the Public Hearing was duly held on December 1, 2010, and due consideration was given to the members of the public who spoke at the Public Hearing; and

WHEREAS, after due deliberation and consideration of this issue, as set forth above, the Board of Education finds that the closing of the E.W. Bower Elementary School will result in an estimated savings to the District and its Taxpayers of \$1.5 million dollars annually; and

WHEREAS, the Board of Education further finds that the E.W. Bower Elementary School is only currently 57% utilized and is projected to be only 48% utilized by the year 2019; and

WHEREAS, the Board of Education further finds that Harding Avenue Elementary School and the West Gates Avenue Elementary School have the functional capacity to accommodate the students from E.W. Bower Elementary School while still meeting their educational needs;

NOW THEREFORE, upon recommendation of the Superintendent of Schools, it is hereby

RESOLVED, that the E.W. Bower Elementary School will be closed beginning with the 2011-2012 school year, and that the students' attendance shall be split between the Harding Avenue Elementary School and the West Gates Avenue Elementary School pursuant to the plan set forth in the Superintendent's Educational Impact Statement.
